(57) **CLAIM**

I claim the ornamental design for a toilet utensils holder, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of my ship design for a toilet utensil holder.

FIG. 2 is a right side view sectional view in elevation of the design shown in FIG. 1, the left side view being a mirror image.

FIG. 3 is a top plan view of my design.

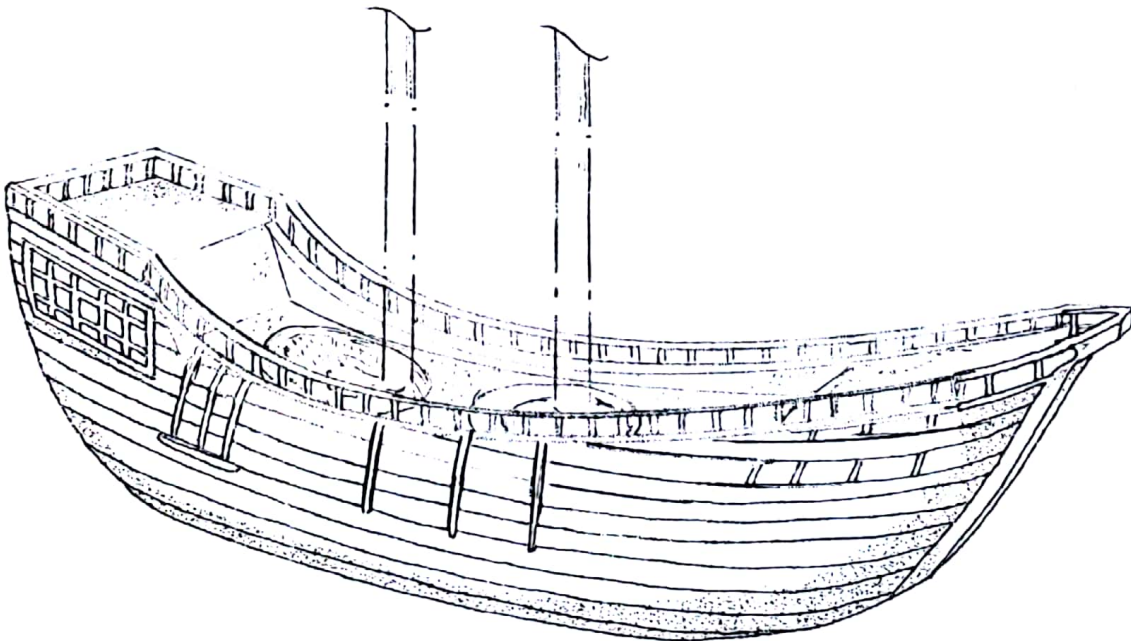
FIG. 4 is a side view in elevation of my design.

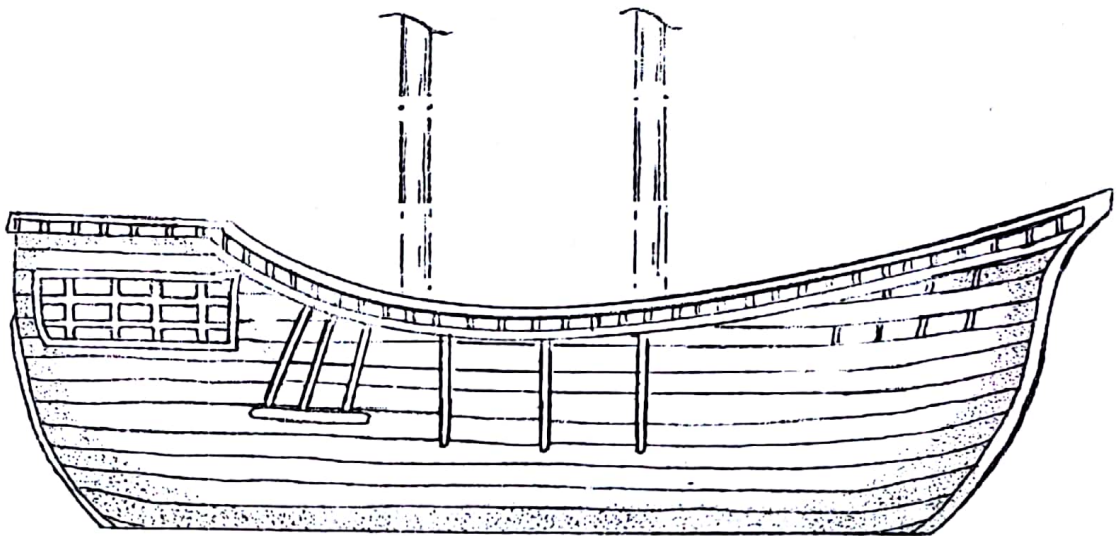

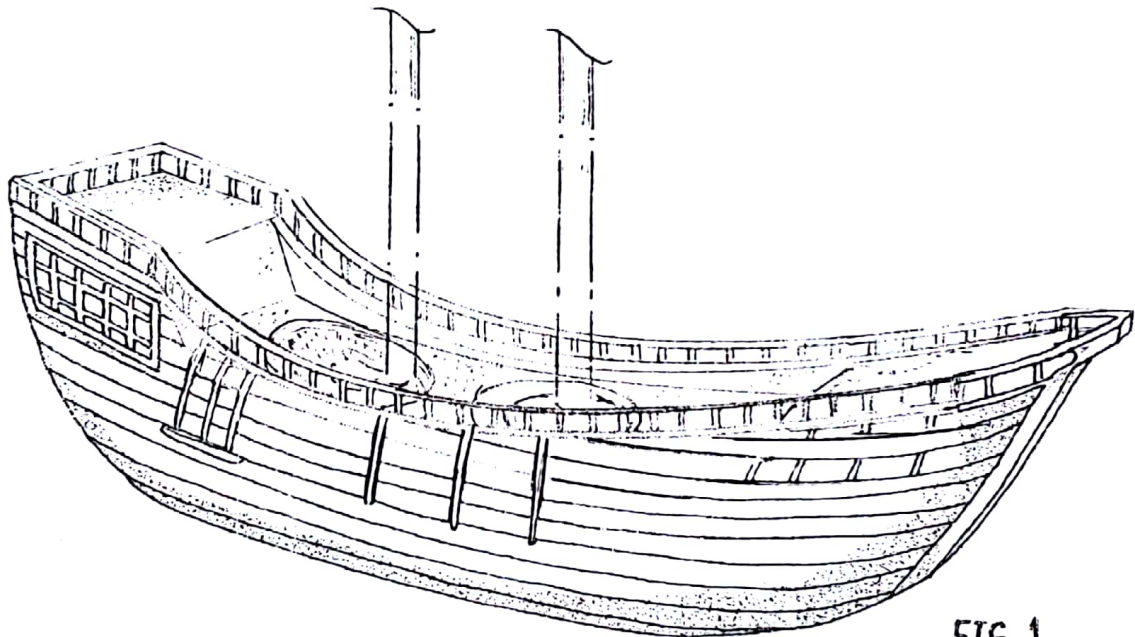

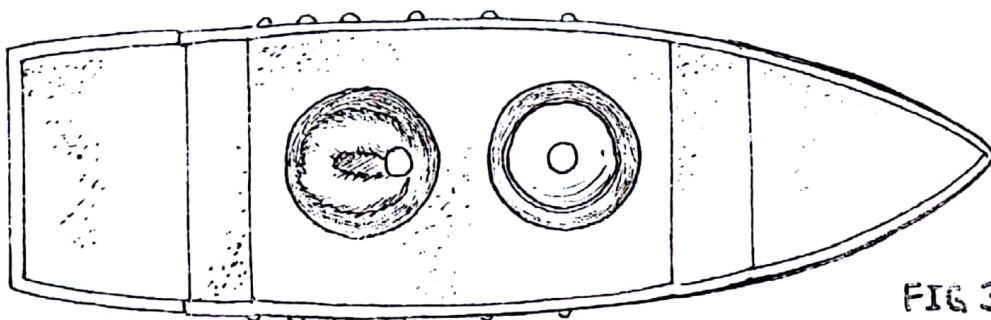

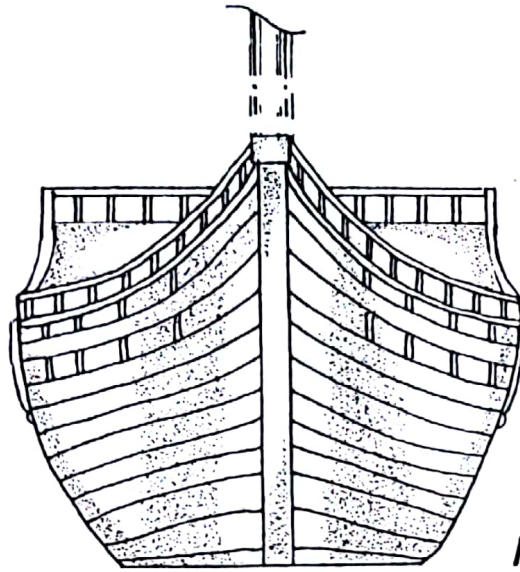

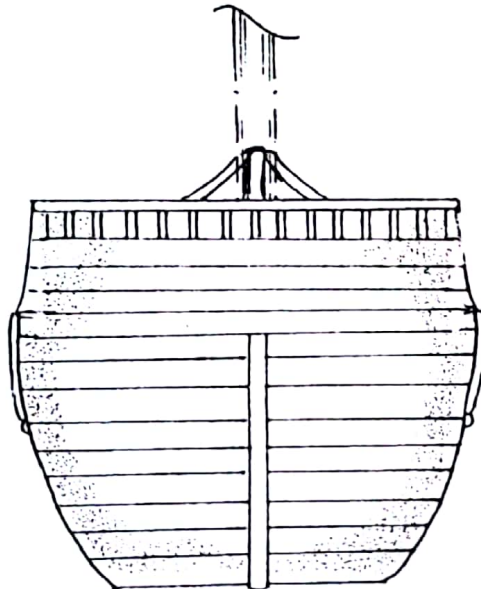

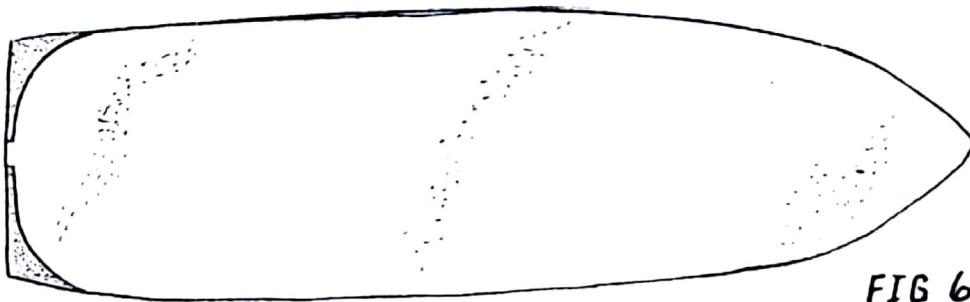
